SINCE THEY LIKE TO REFER TO POLICY WHEN IT SERVES THEM, WHAT ABOUT FLM 5321.061(1) THAT STATES "2. THE NORMAL MINIMUM STAY IN A G.P. UNIT IS 12 MO'S." I'VE BEEN HERE 6 YRS + HAVE 23 YRS CLEAN CONDUCT. BUT I'VE NOT BEEN TRANSITIONED INTO THE STEP DOWN PROGRAM. ON THE CONTRARY I'M DENIED REC. W/ OTHER'S IN G.P. WHICH IS A FAILURE OF THOSE IN CHARGE TO ASSESS ME ACCURATELY + UNBIASEDLY. I'VE DONE NOTHING TO WARRANT THIS. I'M COMPLAINING ABOUT THE ARBITRARY + CAPRICIOUS PUNISHMENT - ISOLATION THAT I'M SUBJECTED TO, ALONG WITH THE MISUSE OF MY 28 YR OLD RECORD TO JUSTIFY WHATEVER SOME ADMINIST-RATOR WILLY-NILLY DECIDES TO DO. AT WHAT POINT DO I START WHERE I LEFT OFF INSTEAD OF STARTING FROM SCRATCH. OR IS ADMINISTRATORS TOO INCOMPETENT OR, + UNWILLING TO INITIATE A VIABLE OPTION OTHER THAN ISOLATION + ADDING MORE RESTRICTIONS THAN THOSE ALREADY ENDURED. AFTER 23 YRS CLEAN TIME + 3 YRS IN G.P. EXPERIENCE / CAPABILITIES. I'M ALL FOR RACIAL - GENDER EQUALITY + HELPING FRIENDS, FAMILY, NEIGHBORS + COHORTS GET A HEAD PROFFESIONALLY. EXCEPT WHEN THEY HOLD MY FATE IN THEIR INEXPERIENCED HANDS THAT THEY MIS-MANAGED INCOMPETENTLY + INCOMPREHENSIBLY THE PAST 28 YEARS. THE FACT THAT I'M STILL ISOLATED PROVES THE MEANINGLESSNESS OF MY PRETEND "EVALUATIONS," + THE ONLY THING THAT THEY CONSIDER IS MY PAST RECORD, WHILE TOTALLY IGNORING WHAT ALL I'VE DONE SINCE THEN. THE ADMINISTRATION REFUSES TO ACKNOWLEDGE + REMEDY THEIR PRACTICE OF HIRING + PROMOTING UNQUALIFIED PERSON'S WHICH HAS BEEN DEVASTATING TO ME SINCE EACH NEW UNIT MGR.: A.W., WARDEN ETC. WHICH IS SO OUTRAGEOUS THAT A SEASONED CORRECTIONAL VET WOULD SURELY FIND AS DISINGENUOUS + LAUGHABLE AS I DO. NEVER THE LESS, THIS SHOW'S THE TYPE REVIEWER'S WHO DECIDE MY FATE. ALL THEY KNOW TO DO + CAN THINK OF IS TO ISOLATE ME. A REAL STROKE OF GENIUS AFTER 28 YR'S. AS WAS MY UNIT MGR. ACTUALLY BELIEVING + TRYING TO CONVINCE ME THAT MOVING ME FROM ONE ISOLATION CELL - UNIT TO ANOTHER JUST LIKE IT "W/OUT ANY ADDITIONAL PRIVILEGES" IS A STEP IN THE RIGHT DIRECTION" + DUE TO MY PAST RECORD, THAT IT'S IMPERATIVE THAT THEY TAKE IT SLOW. THAT'S UNDERSTANDABLE. BUT NO EXCUSE TO KEEP ME ISOLATED WHEN I'VE EARNED MY WAY OUT OF ADX 28 TIMES WORTH, BUT CAN'T GET OUT OF ISOLATION IN A G. P. UNIT + NOT THREATENED LIKE EVERYONE ELSE. THIS IS EXPECTED FROM ADX STAFF WHOSE SO-CALLED "EXPERIENCE" IS DETERMINED BY HOW MANY YEARS ARE SPENT IN THEIR A/C OFFICE SHUFFLING PAPER'S + WALKING THE RANGE PERIODICALLY GAWKING AT THE ENGAGED AS THEY ZOOM BY. THAT'S WHY IT'S NO WONDER THERE ARE SO MANY ELDERLY, PSYCHOLOGICALLY + PHYSICALLY CRIPPLED PRISONER'S HERE WHO SHOULD BE IN REST HOMES + HOSPITALS INSTEAD OF SUBJECTED TO REVIEWS BY INEPT REVIEWER'S UNABLE TO RECOGNIZE ANYTHING OTHER THAN WHATS IN OUR PAST RECORD THAT THEY USE AS A PLOY TO PROTECT THEM SELVES FROM MAKING A DECISION OTHER THAN WAREHOUSING PEOPLE.

I REQUEST TO BE EVALUATED BY QUALIFIED STAFF WHO WON'T LAMELY DECRY AFTER 28 YEARS THAT THEY STILL NEED MORE TIME TO DETERMINE WHETHER OR NOT I CAN FUNCTION SUCCESSFULLY IN A LESS RESTRICTED UNIT + POSSESS THE SOUND CORRECTIONAL JUDGMENT TO THINK OF SOMETHING FAR MORE PROGRESSIVE, EXPEDITE, LESS PSYCHOLOGICALLY DAMAGING + MORE INNOVATING THAN CONTINUING TO PUNISH ME W/ ISOLATION FOR LACK OF A CLUE WHAT TO DO OTHER WISE + THREAT ME EQUALLY W/ OTHER ADX PRISONER'S + SOME ONE WHO ACTUALLY UNDERSTANDS THE CHARACTER OF THE PERSON THEY'RE ASKED / REQUIRED TO EVALUATE W/ A HIGH DEGREE OF CERTAINTY + ABLE TO PREDICT HOW ONE IS LIKELY TO REACT DEPENDING UPON THE ENVIRONMENT HE IS PLACED IN. Your Request for Administrative Remedy dated September 5, 2011, and received in this office on September 12, 2011, has been reviewed. Specifically, you claim discrimination with respect to how we administer your out-of-cell recreation.

A review of the issue raised in your Request for Administrative Remedy has been conducted. The results of the review revealed we administer your recreation in compliance with Institution Supplement, FLM 5321.06J(1), General Population and Step-down Unit Operations. As such, your claim of discrimination remains unsubstantiated.

Accordingly, this response to your Request for Administrative Remedy is for informational purposes only.
